# Carlisle Township Board of Trustees Regular Meeting Minutes – August 18, 2025

The meeting was called to order at 7:00 PM by Trustee Wright

## **Public Participation:**

Resident asked if the Traffic Study on Grafton Road and Indian Hollow had been done. Trustee Smith stated that is County Roads. She also asked about the property on Indian Hollow with the pile of dirt in front of basement is growing a lot of weeds. The owner of the property passed away per Trustee Smith

Resident thanked the Trustees and stated the traffic has been almost nil on Mardun Road

Resident asked if the Trustees are aware that the Lorain County Commissioners are looking for parcels of land to put in Micro Chip Factories, Lithium Battery Plants and Al Facilities in Carlisle Township. This has to do with Jobs Ohio and they are looking at Farm Land because it is cheaper

Resident spoke about a traffic study on Indian Hollow and Grafton Road due to racing vehicles and noise. Trustee Wright stated there are not enough staff on the Sherrif Department to man this road and discussion was had on the issue. Trustee Wright stated these are County Roads and Trustee Smith stated he should attend a Commissioner's Meeting to voice his concerns
